**Minutes:** Minutes were reviewed. Chris motioned to approve. Motion seconded by Jerry and motion carried.

**Voting:** Tax levy ordinance was put to vote. Chris motioned to approve a vote. Motion seconded by Mitchell and motion carried. Tax levy ordinance passed with 4 in favor and 0 no. Ordinance carried.

1974 mobile home, junk cars, and yard maintenance ordinances will we keep as they stand and resign. Bill motioned to keep as is. Motion seconded by Jerry and motion carried. 1974 ordinances passed with 4 in favor 0 no. Ordinances carried.

Annual calendar and open meeting training needs to be completed Jodi and Susan will help with that. All trustees need to do this in the next 3-6 months.

Village of Union Hill website with Carol the cost would be around \$500 it would be like Herscher's site. Mitchell motions to hire Carol to start a Union Hill website. Motion was seconded by Bill and the motion carried. Michelle will help Carol with the set up.

Snowplowing: Union Hill Sales & Service will not do a contract. No other quotes were obtained. UHS&S will do it without a contract, they will provide an estimate of costs it will run around \$1000 for UHS&S to do the snowplowing. Jerry motions that we continue with Union Hill Sales & Service without a contract as we have done for years. Motion is seconded by Grant and the motion carries.

**New Business:** December we will need to do a statement of economic interest.

Attorney for the village is resigning we are currently looking for recommendations.

Michelle will be planning a Christmas party of some sort.

**Treasurer report:** \$ 107841.00 in the account.

Bill motioned to approve the treasurer report. Jerry seconded the motion and the motion carried.

Chris motioned to pay the bills. Mitchell seconded the motion carried.
