**AN ORDINANCE FOR THE LEVY AND ASSESSMENT
OF TAXES FOR THE TAXABLE YEAR 2024**

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF UNION HILL, ILLINOIS:

SECTION I: The total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of \$32,200.00.

SECTION II: There is hereby levied upon all taxable property within the corporate limits of the Village of Union Hill, Illinois subject to taxation for the year 2024, the total sum of \$11,200.00 for the following specific purpose mentioned in said Appropriation Ordinance in the respective sums as follows, to wit:

SECTION III: That the total amount of \$11,200.00 ascertained as aforesaid be, and the same is hereby levied and assessed on all property subject to taxation within the Village of Union Hill, according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.

SECTION IV: This Levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code.

SECTION V: There is hereby certified to the County Clerk of Kankakee County, Illinois the sums aforesaid constituting said total amount and the said total amount of \$11,200.00 which said total amount the said Village of Union Hill requires to be raised by taxation for the current fiscal year of said Village, and the Village Clerk of Union Hill, Illinois is hereby ordered and directed to file with the County Clerk of Kankakee County, on or before the time required by law a certified copy of this Ordinance.

SECTION VI: This Ordinance shall take effect and be in full force and effect immediately on and after its passage and approval.
